#### **Confidential Counseling Services**

Free, confidential counseling can be accessed via Teletherapy or In-Person sessions. Any concerns can be addressed in counseling. Common issues include:

- · Marital, family or relationship issues
- · Depression, anxiety or other mood disorders
- Chronic stress
- · Substance use disorder
- · Work-related issues
- · Grief and loss

## What if a different problem arises after my free sessions are used?

You are limited to 3 counseling sessions per episode of care. If a new concern requires counseling support, you will receive 3 more counseling sessions for the new episode of care.

#### Will my employer be notified?

All EAP services are 100% confidential.

#### What if I need immediate support?

#### **Elder Care Consultation**

Employees and members of their household can access an elder care specialist from Pine Rest for a free consultation. Your consultation will include:

- Suggestions for support groups and other senior care organizations.

#### **Legal Consultation**

### **Unsure Of Where To Refer Someone For Support?**

Please follow the below guidelines to determine when to engage EAP/CAP/SAP services and when other resources should be accessed.

Counseling Session 800.442.0809

#### Use EAP/CAP/SAP benefits to schedule a Counseling Appointment

- Symptoms are mild to moderate and daily activities are manageable.
- Waiting for scheduled appointment seems reasonable.
- The individual is willing to seek assistance.

Hotline 800.442.0809

#### Use EAP/CAP/SAP 24/7 Hotline

- Issue needs to be addressed within the next 2 to 3 hours.
- Individual is not suicidal, intoxicated, or engaging in self-harm behaviors.
- The individual is willing to seek assistance.

Same Day Counseling 616.455.9200

#### Use EAP/CAP/SAP benefits for a one-time, Same-Day Counseling Session

- · Symptoms are moderate and daily activities are manageable.
- Same day counseling is needed to manage until scheduled appointment.
- · Individual is willing to seek assistance and be seen in person.

Urgent Care 616.455.9200

#### Visit Pine Rest Psychiatric Urgent Care Center\*

- Moderate to severe symptoms that need to be assessed and addressed.
- Daily activities are a struggle and without treatment, symptoms are likely to worsen.
- The individual is willing to seek assistance and be seen in person if required.

Inpatient Admission 616.455.9200

#### Call Pine Rest Hospital Admissions\*

- Imminent risk to self or others as a result of mental health symptoms.
- Self-harm thoughts or actions.
- Thought disturbance resulting in risky thoughts and/or behaviors combined with an inability to keep self safe.
- The individual is willing to seek assistance.

Emergency 911

#### Visit a Hospital Emergency Room or call 911\*

- Experiencing extreme agitation and resistant to treatment.
- Experiencing severe psychiatric symptoms (may be related to an acute medical issue)
- Self-harm has occurred and requires medical treatment to stabilize.
- Individual is intoxicated or impaired from substance use.

<sup>\*</sup>Psychiatric Urgent Care, Inpatient Admissions, and Hospital services are NOT covered by EAP/CAP/SAP benefits.
